Collecting and keeping your information safe

SPEVI collects and stores information about members to:

- Maintain contact with members through regular mailings, emailed information, etc
- Inform members about the Association
- Comply with Business and Accounting standards
- Comply with the Australian Taxation Office
- Only the Executive and State Councillors receive this information for their use in the activities of the Association
- Only information from the Membership Application/Renewal Form is kept

How we use your personal information

- Manage our mailing
- Inform you about events and happenings in vision impairment
- Provide information to Government and regulatory authorities, as required or authorised by law (e.g ATO if required)
- We do not supply database information to marketing organisations or disclose information to third parties without your consent, unless required by law

How can you access your personal information?

- To enable us to verify your request we require you to advise your name and current address
